Dr. Clinton is a highly regarded, board-certified pioneer in advanced eye care for dogs, cats, pocket pets, birds, horses, and farm animals. An alumni of the University of Pennsylvania School of Veterinary Medicine, he was a founding member of the American College of Veterinary Ophthalmologists (ACVO) and the first specialist to open a veterinary ophthalmology private practice in New Jersey in 1971.

For over 25 years, Dr. Clinton ran Animal Eye Clinic at The South Jersey Animal Hospital in Medford, NJ. He sold his practice to NorthStar VETS in December 2015. Since merging the two practices, Dr. Clinton has been working with Dr. Vygantas in transitioning his patients and clients into the Ophthalmology service at NorthStar VETS.


